

Opportunity Drawing

Eligibility Requirements, Contest Rules and Regulations

Eligibility Requirements:

Must be at least 18 years of age, and be able to provide proof of age and identity upon request.

Rules and Regulations:

1. By entering the drawing, each contestant agrees to comply with these rules
2. 4. Up to 2,000 tickets per drawing may be obtained by making a contribution of \$100 per ticket.
5. Payments may be made by cash, check, and money order, Visa, MasterCard or American Express.
6. All mailed and/or phoned applications with contribution must be received, with check, money order or credit card number, in the offices of the Charity no later than Friday before the event. Tickets, if available, will be sold at the Pebble Beach Concours d'Elegance on Sunday day of show. All entries must be received no later than 3pm on the day of the event. Official ticket stubs must be fully completed. No mechanically reproduced, computer-generated or any other form of ticket stub will be acceptable. All tickets shall be subject to verification. Charity will destroy all tickets after verification of winner.
7. The opportunity drawing car to be awarded may be on display at the Pebble Beach Concours d'Elegance on Sunday day of show at the Lodge at Pebble Beach, 17 Mile Drive, Pebble Beach, California. Manufacturer reserves the right to provide a like kind vehicle of similar value and not vehicle present on day of show.
8. Winner of the opportunity drawing car will be selected by a random drawing from among all eligible entries received at the Pebble Beach Concours d'Elegance on Sunday day of show at the Lodge at Pebble Beach, 17 Mile Drive, Pebble Beach, California.
9. Winner needs not be present to win. If not present at the drawing the winner will be notified by telephone or certified mail within five business days following the drawing.
10. Winner will work with Manufacturer and designated Charity to complete an affidavit of eligibility and liability release within ten (10) calendar days of notification thereof or the prize may be forfeited. Winner will be required to take possession as required by the

Manufacturer. If Winner does not claim the prize, is unable to take possession within the above time frame, or is ineligible to take possession for any reason, an alternate winner will be drawn.
